1. **Opening** – Opened at 18:03.

5. Current State of Affairs

Kirsten Koolhof: We will give you a little update how everything went so far. Since the COVID-19 we had to close the room and cancelled a lot of our activities. But we find it really important to keep in touch with the members, so we work still with each other and the online events.

6. Update on Policy

Kirsten Koolhof: I will now give you an update on the Policy Plan: efore we start, you can also find it back at the VSPVU website. Due to these weird times, we will of course not be able to do all of our policy points, but I will still go through them right now if they are relevant right now.

- a. Commitment:
 - i. Mini Events:

Kirsten Koolhof: We had a lot of Mini Events in real life, now we are trying to put them online. Some of them are better than others, but we are looking into the best options to keep in touch with the members. If you have some ideas for Online Mini Events, please let us know. ii. Transparency:

Kirsten Koolhof: We are sending out a monthly newsletter with information about the Board and its events.

- iii. External Relations: Kirsten Koolhof: This is hard right now, but we have been in really close contact with faculty and for promotion for example the Candidacy Board throughout Faculty.
- iv. Merchandise:
 Kirsten Koolhof: We still have the merch we bought; we are looking into still selling it online. We are working on concrete ideas right now.
- v. VSPVU-room: Kirsten Koolhof: We regularly check the room and made sure all of our important / expensive stuff is out of it and somewhere else.
- b. Members:
 - i. New Members:

Kirsten Koolhof: We have a total of 474 new Bachelor members and 15 new Master members, so we have to get 10 more members. We worked on ideas how to get 10 more members. This will be for new Bachelor students next year and the promotion will be through the Faculty. But we don't necessarily expect any new members this year.

ii. Member Initiative:

Kirsten Koolhof: We had two Member Initiatives, and one of them happened which we think was a big success, the other one got canceled due to COVID-19, which was sad.

- Sjoerd van den Assem: There were a lot of beer glasses in the room for the beer tasting, is there a possibility that they can be picked up?
- Alessia van Overbeeke: The glasses are still in the room so if you really want to pick it up before the summer you can ask us and we'll look, and otherwise it is after the summer break.
- Sjoerd van den Assem: Okay cool I'll let the people know then.
- iii. Workshops:

Kirsten Koolhof: We finally have our first workshop planned. It will still be on the 13^{th} of May and online. It will be a workshop about personal branding and the costs will not be more than a maximum of \in 5,00 per person.

iv. Active Member Application:

Kirsten Koolhof: We are not focusing on this right now, since the committees are going smooth and there is no relevance right now due to COVID-19. We are thinking of promotion ideas for new chairmen for next year.

- c. Recognition:
 - i. Media:

Kirsten Koolhof: We invest more in Facebook and Instagram paid promotion. We updated our LinkedIn and we added Externals.

ii. Website:

Kirsten Koolhof: Genkgo, the website host, has updated our website with a new layout. We also look into options to make it as useful as possible.

- d. Awareness:
 - i. Environment:

Kirsten Koolhof: We have the reusable cups we bought just before everything happened. We are looking into options to use them on events later in the year or in another way.

ii. Safety:

Kirsten Koolhof: We are sticking to the requesting plan for the board pass, but not really needed right now.

- e. Policy Continuation:
 - Translation and Internalization:
 Kirsten Koolhof: We were planning on the language courses, which got cancelled.
 But we do advise next years' Board to organize it.
 - ii. General Meeting: Kirsten Koolhof: We will have one later this year in June and one after the summer.
 - iii. General Board Meetings:Kirsten Koolhof: We had 6 General Board Meetings and the final one is in June.

iv. Meetings:

Kirsten Koolhof: We are still attending meetings like LOOP, SSPN and G5 online.

- v. Functioning: Kirsten Koolhof: We had a few function trainings, but not all of them happened due to the COVID-19. It is difficult to have a training but because it is important some of the Active Members got an online training.
- vi. Birthday Cards:

Kirsten Koolhof: Birthday cards are written and send, but there is a huge delay of more than 27 days to send it out from the island. So, wait and see.

vii. Budgets:

Kirsten Koolhof: We ask the Financial Audit to check double things and for advice.

viii. Education:

Kirsten Koolhof: We planned to have a tutor borrel on the 19th of March. It got cancelled but we advise next Board to organize it.

- ix. First Aid Course:
 Kirsten Koolhof: Everybody received their license for the First Aid Course, and everybody picked it up.
- x. Alcohol & Drugs Policy: Kirsten Koolhof: Up to now we used the policy once, and we are sticking to it.

7. Update Financial Statement

Kirsten Koolhof: I will give the word to Alessia van Overbeeke for an update of the Financial Statement.

Alessia van Overbeeke presents Income

- Margot Bakkes: I was wondering, because we are quite far in the year and sponsorship was lacking behind. Was there a concrete reason and do you have tips to prevent that?
- Alessia van Overbeeke: Yes, look into sponsoring way sooner and way more concrete, because we were focusing on environment too much at the start and that is where we fell behind. And now with these times it sucks to get sponsors.

Alessia van Overbeeke presents Board Activities

- Sjoerd van den Assem: I've got two questions: The first one is practical: ou have money on transition weekend which is important but in May, and since events are not allowed are you going to be able to join face-to-face? And if not why 150 euros?
- Alessia van Overbeeke: We can also meet after the 20th of May and since it's a small group of max 11 people we might be able to do it and otherwise look into doing it online but then with nice paid stuff like an online training or so.

- Sjoerd van den Assem: And secondly, I think the second idea is really nice, but will you tell us more about what it is later?
- Alessia van Overbeeke: No, we have it as a surprise: hat I can say is that it's for a day but otherwise it's a surprise.
- Sjoerd van den Assem: Because then I feel like voting for something over 2000 euros is something off and weird to do.
- Liz Masselink: Is there money coming back on Mini Events?
- Alessia van Overbeeke: Yes, because there is deposit in the room still.
- Juli Dylla: Is it an online activity for active members?
- Alessia van Overbeeke: No, it's not online.

Alessia van Overbeeke presents Committees

- Liz Masselink: When will the Convention be and all activities are cancelled until January?
- Alessia van Overbeeke: We cancelled all until the summer break and the VU decided to cancel activities like Parents' Day until January, but because Convention is on another location it's fine.
- Liz Masselink: Study trip: Do they need to go to that location from KLM?
- Alessia van Overbeeke: No, they can choose another location.
- Sjoerd van den Assem: Why did you lower the money for the Lustrum Committee?
- Alessia van Overbeeke: Because that was the last post that if that one is lowered is not that bad, and since we did not have enough money to invest the same in it as usual its lowered.
- Sjoerd van den Assem: Okay and what happens with the Faculty budget to cancelled events, like the Convention?
- Alessia van Overbeeke: We already get 500 euros extra for it, but they had 1400 euros on sponsoring: o, they get 500 euros from Faculty and 1000 euros from VSPVU.
- Sjoerd van den Assem: Yes, but I mean overall budget.
- Alessia van Overbeeke: We did but they are being very hard about that. They try to work with us, but they have a huge loss as well so in this way we are helping them as well. This is kind of an in between.

Alessia van Overbeeke presents Board Expenses

- Liz Masselink: Maybe it's nice to look into how much fixed costs there are for next year to have a more specific overview.
- Alessia van Overbeeke: Yes, that is a nice comment.

 - Liz Masselink: Is there a plan B if we are not allowed to go into big groups?
 - Kirsten Koolhof: We haven't book anything so that's save, but we did not think of alternatives yet as we don't know what happens otherwise.

• Alessia van Overbeeke: And we are very careful with signing contracts for it surrounding COVID-19 policies or anything else.
