

# GENERAL TERMS AND CONDITIONS

## I. IDENTITY OF ASSOCIATION AND DEFINITIONS

VSPVU is the study association of Psychology and Child Studies at the Vrije Universiteit. VSPVU operates under KvK number 40537542. Adress: Van der Boechorststraat 7, room D056, 1081 BT, Amsterdam. Phone number: 020-5988919.

## II. APPLICABILITY

1. The terms and conditions apply for the membership of the VSPVU. By becoming a member of the VSPVU, you confirm that you are familiar with the terms and conditions and that you agree with all the membership related activities of the VSPVU as described in the articles of the general terms and conditions.
2. If you do not agree with any of the statements in the general terms and conditions, please submit a written request to [board@vspvu.com](mailto:board@vspvu.com) (prior to becoming a member). VSPVU will consider a different arrangement and will give notice of this within 14 days. If you do not agree with any of the statements in the general terms and conditions, you may be restricted from activities provided by the VSPVU.
3. Exceptions from the general terms and conditions can only be made written with a signature of both parties (the student and the VSPVU).

## III. MEMBERSHIP

### *General*

1. Membership is open to everyone.
2. Your membership is personal and you cannot transfer your membership to another person. You are responsible for the password of your account on the VSPVU website and you are not allowed to grant access to any third party under any circumstances.
3. If you would like to continue your membership, you have to renew it at the start of every new academic year. If you wish to end your membership, you can terminate your membership.
4. VSPVU has the right to terminate a membership for any reason, at any time, with notice.

### *Duration*

1. You can become a member at any period in time.
2. You are a member until termination. Termination can be done by the member or by the VSPVU during the entire year. The member can terminate the membership by sending an email to [board@vspvu.com](mailto:board@vspvu.com).
3. The membership will end automatically when the person dies.

## IV. EVENTS

1. At every VSPVU event, the Alcohol and Drug policy will be lived up to.
2. In case of cancellation or relocation of a VSPVU event, VSPVU will inform the members as good as possible.
3. In case of cancellation of a VSPVU-event due to circumstances outside of the control of the VSPVU, the VSPVU is not liable for paying back costs of participation

## V. CONTRIBUTION

1. A member pays 35 euros for the first year to be a member.
2. After the first year, the annual fee for the membership will become 5 euros per year.
3. The collection of yearly contribution will be announced to the member prior to the collection and will only happen when a member decides to approve the continuation of their membership.

## VI. PRIVACY

1. When you become a member of the VSPVU or when you apply for a committee membership, you provide the VSPVU with some personal information. By uploading/sending this information to the VSPVU-website or by filling in an authorization form, you grant the VSPVU an irrevocable, unconditional, unlimited, perpetual during membership (when the membership is terminated the data will be kept for a maximum of 1 year) and royalty-free license to use this data or any part of this, in any way it seems fit under the laws of the AVG, in published media (except for copies of passports/identity cards and personal data on CV's).
2. When a member wants to have insight in his or her personal data obtained by the VSPVU, the member can contact the VSPVU by sending an e-mail to [board@vspvu.com](mailto:board@vspvu.com).
3. Whenever a member wants to change his or her personal information, this can be done via the website or by contacting the VSPVU by sending an email to [board@vspvu.com](mailto:board@vspvu.com)
4. VSPVU uses you information for promotional purposes of VSPVU-services and -events and for commercial purposes (for example by sending you e-mails).
5. VSPVU is allowed to process the data that you fill in on the VSPVU-website and to save them into one or more files

6. VSPVU is allowed to process the data that you fill in on authorization forms and to save them into one or more files.
7. VSPVU is authorized to share the VSPVU membership information with the Vrije Universiteit Amsterdam.
8. By sending an email to [board@vspvu.com](mailto:board@vspvu.com), a member can declare that they do not agree with VI.4. The VSPVU will then not use your information for these purposes
9. VSPVU is allowed to make pictures during events which can be used for promotional purposes or can be used on social media. If requested, participants can be left out of pictures or not be posted on social media. This request can be done through [board@vspvu.com](mailto:board@vspvu.com).

## **VII. GUARANTEE OF ACCURATE AND TRUE INFORMATION**

1. You warrant the VSPVU a guarantee that all the information that you enter in the registration form or anywhere else on the website of the VSPVU while using it, is accurate and true. If the VSPVU has a valid reason to believe that the information provided is incomplete, untrue, misleading or incorrect, the VSPVU is entitled to delete the information, and if so wishes, to terminate the membership entirely.

## **VIII. CHANGES**

1. The VSPVU has the right to change the general terms and conditions of the VSPVU in any moment in time when the VSPVU considers this as necessary, without prior notice. The new general terms and conditions will be published on [vspvu.com](http://vspvu.com) and members are recommended to check the website regularly.

## **IX. LIABILITY**

1. The VSPVU is not liable for any loss, theft or damage, of whatever nature, in possession of participants of activities or users of the services/events of VSPVU. The VSPVU is also not liable for the consequences or indirect damage of the not /not in time/not right performance of The VSPVU.
2. The VSPVU is not liable for any damages resulting from the use of the VSPVU-website.
3. The VSPVU is not liable for any information or communication that is not provided by the VSPVU.
4. The VSPVU is only liable for the damage which is a direct consequence of an accountable mistake of the VSPVU in the execution of the obligations of the VSPVU as mentioned in the general terms and conditions.
5. The VSPVU is not liable in case of intentional damage by the student or in the case of recklessness.

## **X. INTELLECTUAL PROPERTY**

1. VSPVU holds the rights and qualifications which belong to the VSPVU according to the Dutch copyright law and other intellectual law and regulations. The VSPVU is allowed to use this for other purposes.
2. Everything on the website of the VSPVU belong to the VSPVU. If you find any material on the website which you believe infringes any third party or property right, please contact the VSPVU. The VSPVU cannot be held responsible for the information provided on the website.

## **XI. APPLICABLE LAW AND COMPLAINTS**

1. The Dutch law is applicable on the general terms and conditions of the VSPVU.
2. In the event when one or more terms of the general terms and conditions are void or voidable, the concerning term will be replaced by a valid provision that has the same effect.
3. Complaints about the execution of the agreement should be submitted to the VSPVU by the members within reasonable time, clearly defined and compete after the member established a deficiency. This complaint will be answered.

## **XII. ADDITIONAL TERMS**

1. Additional general terms and conditions should not be at the expense of the members and they should be submitted written in a way that the member could store it.

3. Breaking one of the articles mentioned in the general terms and conditions can be sanctioned by the VSPVU.

5. The communication between the VSPVU and its members can be done written, oral and electronically.
